Applications are invited in the prescribed format from the eligible candidates for the posts of Assistant Professor in following disciplines (Super Speciality) to work in the AHPGIC establishment. The appointment will be in accordance with the Odisha Medical Education Service 2021 & as per AHPGIC Bye-Law (Published in the Odisha Gazette No. 1607, Cuttack September 30th, 2021).

1. **Age limit as on 01.01.2025** : For eligibility to apply for this post, a candidate must be below 45 years of age as on 1st January 2025.

Provided further that the upper age limit up to 5 (Five) years shall be relaxed in case of in-service doctor under the Govt. or Govt. undertakings as the case may be.

Date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board / Council will be accepted by the Selection Committee.

2. **Scale of Pay:** As per ORSP (MCT) Rules-2019(Govt. of Odisha guideline).

DNB The Diplomat of National Board (DNB) in broad speciality and super speciality qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examination, shall be equivalent in all respects to the corresponding broad speciality (MD/MS) and Super Specialty (DM/M.Ch) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.

4. Selection Procedure:

The weightage for different examinations shall be as under :

(In case the candidate has passed PG before 2016 / 2017 MBBS mark awarded will be 40% in place of 20% for MBBS and 20% for PG)

One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

The Selection Committee shall prepare a list of candidates in order of merit on the basis of above criteria.

Provided that, if two or more candidates secure equal marks, then the candidates securing higher marks in MBBS examination shall find place above the other in the merit list. In case marks obtained in MBBS Examination is also the same, the candidate older in age shall be placed above the younger.

The prescribed Eligibility qualification is minimum and mere possessing the same does not entitle any candidate for selection. The methodology of selection will be decided by the Selection Committee as deemed fit besides any other matter related to the selection process.

The list recommended by the Selection Committee shall remain valid for a period of one (01) year from the date of its approval by the Government. There is provision for wait list.

5. Place of Examination :

The place & date of interview shall be notified well in advance. No TA/DA will be paid for appearing in the interview.

6. Other Eligibility Conditions :

- (i) The candidate must be a citizen of India;

- (ii) The candidate must be of (a) good moral character, and (b) good mental conditions and bodily health, good physique and active habits and free from organic defects or bodily infirmly so as not to create an impairment in the due discharge of duties;
- (iii) A candidate, who has more than one spouse living, will not be eligible for appointment unless the State Government has exempted his/her case from operation of this limitation for any good and sufficient reasons;
- (iv) Government servants, whether temporary or permanent, are eligible to apply provided that they possess the requisite qualification and are within the prescribed age-limit as provided Para 3 & 1 of the Advertisement. They must inform their respective Heads of the Office in writing regarding submission of their application for this recruitment and furnish "No Objection Certificate" during document verification;
- (v) Before appointment, a candidate must register himself / herself under the Odisha Medical Registration Act, 1961.
- (vi) **Only those candidate, who possess the requisite qualifications, are within the prescribed age limit and fulfill eligibility conditions etc. by the closing date for submission of application form, will be considered eligible;**
- (vii) A candidate who claims change in his/her name after having passed the HSC examination, is required to furnish copy of publication of the changed name in the local leading daily newspaper as well as copy of notification in the Gazette in support of his / her change of name;
- (viii) Every candidate selected for appointment shall be examined by the Medical Board. A candidate, who does not satisfy the requirement after medical examination, shall not be appointed.

7. Application Fees:

A recruitment fee of **Rs. 1,000/- (One Thousand only)** is to be deposited through only Demand Draft in favour of **Director, AHPGIC, Cuttack payable at SBI, SCB MCH Campus Branch, Cuttack**. Candidates applying more than one discipline should submit multiple nos. of Bank Draft, as applicable.

8. Important Notes :

- (i) Applications submitted to AHPGIC, if found to be incomplete in any respect, are liable for rejection without entertaining any correspondence with the applicants on the score;
- (ii) A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or applying, pressure on any person connected with the conduct of the recruitment process or indulging in any types of malpractice in the course of selection or otherwise, shall, in addition to rendering himself / herself liable to criminal prosecution, be disqualified not only for the recruitment for which he / she is a candidate, but also may be debarred, either permanently or for a specified period, from any recruitment or selection to be conducted by Selection Committee, AHPGIC.
- (iii) If on verification at any stage before or after the interview it is found that a candidate does not fulfill all the eligibility conditions, his / her candidature will be liable to rejection. Decision of the Selection Committee in regard to eligibility or otherwise of candidate shall be final;

- (iv) This advertisement should not be construed as binding on the Government to make appointment;
- (v) Any misrepresentation or suppression of information by the candidate in the application form will result in cancellation of his / her candidature or penalty, as decided by Selection Committee;
- (vi) Mere empanelment in the select list shall not confer any right for appointment unless the Government is satisfied after making such enquiry as may be deemed necessary that the candidate is suitable in all respects for appointment to the service;

9. Certificates / Documents to be Attached :

Candidate who will qualify in the interview will be required to bring with them the hard copy of application form along with copies of following relevant certificates / documents and originals of the same for verification of their eligibility as per terms and conditions of the advertisement, the date of which will be notified later on in due course, failing which his / her application will be rejected for the said post. The candidates are required to mention on each copy of documents "Submitted by me" and put their full signature and date of the same. **They must not attach the original certificates to their applications.** Those who want to apply for multiple discipline should submit separate application form with bank draft.

- (ii) H.S.C certificate and mark sheet or equivalent certificate in support of declaration of age issued by the concerned Board / Council.
- (iii) +2 / equivalent examination certificate and mark sheet .
- (iv) MBBS certificate and mark sheet issued from the recognized University.
- (v) Houseman-ship Completion Certificate.
- (vi) All chance certificate of MBBS / MD / MS / DNB / M.Ch.

Note :

Candidate who have not been awarded percentage of marks, but only grade marks, should along with their applications, produce the conversion certificate from the concern University including the actual equivalent percentage of marks and the conversion formula, failing which, their applications are liable to be rejected.

- (vii) M.D / M.S / D.M / M.Ch / DNB certificate and mark sheet in support of qualification in the concerned Super Speciality discipline as may be applicable issued by the concerned University / Institution recognized by MCI / NMC;
- (viii) Experience Certificate from the competent authority for working as a Tutor / Senior Residency certificate - if any.
- (ix) Latest Medical Registration Certificate as per the Medical Registration Act, 1961.
- (x) Certificate relating to passing of the screening test conducted by the National Board of Education as prescribed by the National Board of Education as prescribed by the Medical Council of India vide Notification No.MCI-203(9) Regn. 2001, dated 13.02.2002 for Medical Graduate passing out of a foreign University;
- (xi) No Objection Certificate issued by the competent authority;
- (xii) Two recent passport size photographs (unsigned and unattested) with the printout / hard copy of online application form which has been uploaded;

- (xiii) Any proof of identity;
- (xiv) A Demand Draft of Rs. 1,000/- (One Thousand only) in favour of Director, AHPGIC, Cuttack payable at SBI, SCB MCH Campus Branch, Cuttack.
- (xv) Certificate from Competent authority in support of past service as in-service doctor serving on ad hoc basis or contractual basis under Government of Odisha in respect of candidates, who claim age relaxation as serving Doctors. The period of past service will be taken into account by the closing date of receipt of application.

NOTE : 1. **M.Ch / D.M / DNB / DNB-SS Degree Certificate and teaching experience must have been issued by the competent authority within the last date fixed for submission / receipt of application form.**

2. MD/MS/DNB degree certificate & 3 years Special Training in concerned super speciality subject in a teaching institute/ center of excellence with dedicated service in that speciality must have been **issued by the competent authority within the last date fixed for submission / receipt of application form.**

10. "Grounds of Rejection of Applications" :

Applications of candidates will be rejected by the Selection Board on any of the following ground.

- (a) In-complete application form.
- (b) Non-submission of hard copy of application form at the time of verification of original documents.
- (c) Not signing Declaration (full signature) in the hard copy of application form.
- (d) Not coming within the age limit as mentioned in Para-1.
- (e) Not having requisite qualification as provided under Para-3.
- (f) Not furnishing copies of certificates / documents as provided under Para-8.
- (g) Submission of wrong information / false information about qualification / Age.
- (h) Suppression of facts / information about eligibility, if any.
- (i) Any other ground as per the decision of the Selection Committee.


NB : Application / candidature of a candidate shall be rejected at any stage of recruitment process and thereafter when discrepancy is noticed / detected.
