TENDER CALL NOTICE

Sealed tenders in two-bid system are invited from registered, eligible, experienced & reputed agencies for **“Comprehensive Maintenance Contract of the Medical Gas Pipeline System for OT & SICU “** for a period of 2 years. The tenders should reach in the office of the undersigned by 10.06.2025 at 5 PM through Registered Post/Speed Post only, which will be opened on 11.06.2025 at 1:00 PM in the office chamber of the Director, AHPGIC, Cuttack.

General Terms and Conditions :

1. The sealed bids are to be submitted in prescribed format on your business letter head duly stamped and signed and dated on each page of Part 'A' & 'B'. No overwriting shall be accepted unless authenticated with full signature of the vendors.
2. Each bidder shall submit the offer in two separate sealed envelopes, Part A & Part B. (Part A - Technical Bid”), (Part B - Financial Bid”). Both the sealed envelopes are to be put in the main envelop.
3. The bids duly super scribed **“Comprehensive Maintenance Contract for the Medical Gas Pipeline System of OT & SICU “** , should be addressed by name of **The Director , Acharya Harihar Post Graduate Institute of Cancer , Cuttack** and sent at the office address by registered post/speed post only & should reach on or before the last date and time.
4. The tenderer should furnish EMD of Rs.10,000/- (refundable) in the form of DD in favour of **The Director , Acharya Harihar Regional Cancer Centre , Cuttack**.
5. No tender documents can be accepted at any circumstances after the expiry of scheduled date and time for receipt of bids.
6. Each and every page of the tender document should be serially numbered and duly signed by the tenderer with stamp.
7. All entries in the tender form should be legible and should be filled carefully and clearly.
8. The firm should quote rate in Indian currency excluding GST both in word and digit.
9. The firm has to give preventive visit in every month and unlimited breakdown call during the period. If the firm fail to provide preventive visit in any month proportionate amount will be deducted from CMC charges. The preventive visit should be made in first week of every month and this is not related to any breakdown call.

10. The firm should furnish the CMC service for maintenance of Central Medical Oxygen suction and air pipeline along with accessories indicated in Annexure – II under control of medical OT & SICU of this institute.
11. The firm should quote the rate for CMC including any parts / spares / consumables including oil during maintenance of the aforesaid unit.
12. The bidders may visit the site before submission of the tender.
13. The bidders must have a service centre near to this Institute preferably at Cuttack & BBSR.
14. The successful firm must attend the call immediately within 24 hours of receipt of complain.
15. The firm has to enter in to an agreement after which work order shall be issued.
16. The selected firm has to fix a signage mentioning contact number in the ward for immediate logging of complain round the clock where maintenance is to be done.
17. Dispute if any with regard to the tender shall be settled in the court in the jurisdiction of Cuttack , Odisha.

ELIGIBILITY CRITERIA

1. The firm should have satisfactory work experience of minimum one year in Govt. / private hospitals in Installation or maintenance of Central Medical Gas Pipeline System i.e. Central Oxygen , Vacuum & air pipe line system.
2. The firm should be registered in State or Central Govt. (GST)
3. The firm should not be blacklisted either by the Tender inviting authority or by any State Govt or Central Govt. organization.(Annexure – III)

1. EMD of Rs. 10,000 (Ten thousand) in shape of Demand Draft in favour of **The Director , Acharya Harihar Regional Cancer Centre , Cuttack.**
2. GST registration certificate.
3. Photocopy of PAN card of the firm / proprietor.
4. Up-to-date GST clearance certificate.
5. Tender paper cost of Rs. 2000/- (Two thousand) in the shape of DD in favour of **The Director , Acharya Harihar Regional Cancer Centre , Cuttack.**
6. Copy of minimum one year work experience in installation or maintenance of Central Medical Gas Pipeline System must be submitted in support of experience (mandatory).
7. Declaration through affidavit before Notary Public / Executive Magistrate regarding non-blacklisted by any State Govt. or Central Govt. organization. (Annexure – III)
8. Detail name , address, telephone no., e-mail of the Agency / authorised distributor .

EMD

1. The EMD of the unsuccessful bidders will be returned back after finalization of the tender without interest.
2. The EMD of the selected firm will be refunded after submission of security deposit.

SECURITY DEPOSIT:



The selected firm has to submit security deposit of Rs.25,000/- in the form of the DD to be pledged in the name of the ***The Director, Acharya Harihar Regional Cancer Centre, Cuttack.*** *If the firm did not take up the work after submission of security deposit then order will be cancelled and security amount will be forfeited.*


PRICE EVALUTION

1. Tenderers who technically qualify after scrutiny of documents will be evaluated only.
2. The lowest price quoted as a whole by the bidder will be selected.

PAYMENT PROCEDURE:

1. Payment shall be made after submission of the bill in triplicate along-with satisfactory service report duly signed by Gas Technician and counter signed by HoD Anaesthesiology.
2. The payment towards CMC shall be made directly on 6 monthly basis after satisfactory completion of the CMC period. That there will be 95% uptime warranty during CMC period on 24 (hours) x 7 (days) x 365 (days) basis with penalty in the form of extended CMC period by double the downtime period if the system goes out of order .
