Advertisement for filling up posts of Assistant Professor (Contractual)-2025

Date of Walk-In- Interview Verification of Documents & Counselling: 12.02.2025 (Attendance: at 10 A.M. – 11 A.M., Verification 11.00 A.M. – 02.00 P.M.) Venue: Lecture Hall-1, Acharya Harihar Post Graduate Institute of Cancer, Cuttack

Eligible candidates are invited for <u>walk-in-interview</u> for the selection of the posts of Assistant Professor (Contractual) in different disciplines of Acharya Harihar Post Graduate Institute of Cancer, Cuttack, on Contractual / Deputation basis in view of MCI / NMC urgency. The direct candidate shall be appointed on contractual basis & the in-service candidates shall be appointed on deputation basis for a maximum period of four years or till the regular appointment is done. The applicant must have acquired the required qualification for the post applied for on or before the date of counselling i.e 12.02.2025. The candidates who are continuing as faculties in any of the Govt. Medical College of the State, VIMSAR, Burla either on contractual / deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three (03) years.

#### 1. Available vacancy:

The provisional vacancy is attached in Annexure-I.

- **2. Age**: Must be less than 69 years on the date of interview for the post of Assistant Professor (contractual). (The maximum age up to which one can serve is 70 years)
- 3. Eligibility and Qualifications for Assistant Professor (Contractual):
  - a. Qualification:

The candidate must possess MD / MS / DNB / M.Ch or equivalent degree in the concerned disciplines from any MCI / NMC approved / recognized / permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as desired by the NMC and as per "Teachers Eligibility Qualifications in Medical Institute Regulations 2022" and "Guidelines for Under Graduate Courses under Establishment of New Medical Courses, Increase of Seats for Existing Courses & Assessment and Rating Regulations, 2023" of NMC, in force and OMES Rules 2021.

- b. Other eligibility conditions:
  - i. The candidate must be a citizen of India.
  - ii. The candidate must have registered himself / herself under any State Medical Council / MCI / NMC after obtaining the degree

#### 4. Selection Process:

- The candidates are directed to bring original documents for verification on the date of counselling at Lecture Hall-1, AHPGIC, Cuttack – 753007.
- b. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation Intermediate Science MBBS

- 20% of total percentage of marks secured.
- 20% of total percentage of marks secured.60% of total percentage of marks secured.

(In case the candidate has passed PG in 2016/2017 or after wards MBBS-30% and PG-30%)

One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

- c. In case of tie it will be resolved as follows: The candidate securing more mark in MBBS shall be placed in higher rank. In case of further tie the elderly candidates shall be placed higher in rank to the younger.
- d. The direct candidates must report before the authority of the Institution allotted within seven days of issue of appointment order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.
- 5. In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification/ counselling/ choice filling physical presence of the candidate is mandatory and no authorization will be entertained.
  - a. After successful verification of documents a provisional merit list shall be prepared and notified.
  - b. The decision of the selection committee will be final and the result will be intimated to the selected candidates in time.
  - c. Selection shall be made on the basis of merit and shall be uploaded in the website of www.ahpgic.in. Appointment letter shall be issued in favour of selected candidates.
  - d. Any clarification / corrigendum / addendum to this advertisement is required shall be issued by AHPGIC, Cuttack and shall be final and binding and will be a part of the advertisement.
  - e. All communication shall be made through the website of AHPGIC, Cuttack i.e www.ahpgic.in.
  - f. A recruitment fee of Rs. 500/- (Five Hundred only) is to be deposited through only Demand Draft in favour of Director, AHPGIC, Cuttack payable at SBI, SCB MCH Campus Branch, Cuttack. Candidates applying more than one discipline should submit multiple nos. of Bank Draft, as applicable.

#### 6. Terms and Conditions:

All the terms and conditions as per Govt. letter issued from time to time shall be applicable.

- a. The contractual Assistant Professors are entitled for remuneration of Rs. 1,20,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time to time.
- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a maximum period of four years subject to satisfactory performance. However, AHPGIC reserves the right to terminate the services of the faculty with one-month prior notice from either side.
- d. All the communications shall be made through the website of AHPGIC, Cuttack www.ahpgic.in and no personal communication shall be made.
- e. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.04.2022.
- f. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisement for three years.
- g. The terms and conditions will be followed as per the Govt. Guidelines issued vide Resolution No. 8967 Dt. 25.04.2022.

h. The Director reserves the right to reject any or all applications and selection, without assigning any reason thereof.
